### **Terms and Conditions**

#### **VRC Members – L’Oreal Melbourne Fashion Festival Promotion**

- 1) Information on prizes and how to participate forms part of these terms and conditions.
- 2) The Promoter is Victoria Racing Club Limited (ACN 119 214 078) of 448 Epsom Road, Flemington VIC 3031.
- 3) Entry is only open to individuals who have followed the correct entry process. Employees, directors and other representatives of the Promoter and organisations involved in sponsoring or conducting this promotion (and any individuals so involved) are ineligible, as are members of their immediate families and households.
